Students and teachers in most of the parts of our country are instructed to have online classes and therefore the inclined towards usage of Social Media has also increased and the abundant use of Social Media is resulting in bad academic performance of students and lack of awareness, knowledge, and preparedness regarding the use of the Internet is leading to Cyber Crime. The study will find out that there is a relationship between Social Media and Academic performance and also the excess use of Social Media is leading to Cyber-crime.

Cyber Crime refers to any criminal activity carried out through the use of ICTs and the internet (Gordon and Ford, 2006). The unawareness regarding privacy policies also affects them especially young girls. Cyber Criminals use fake profiles to connect with them and then they morphed their pictures, use their identity or cyberbullying are some of the major crimes that have been seen because of more usage of Social Media.

The more popularity of this platform has changed the lives of many. The excess use of these sites is causing problems like headaches, depression, divorce, suicide, etc.

3. Social Media: Usage and Impact

Martin and Erickson (2013), opines that social media act as a powerful tool to maintain social relations virtually in the 21st century which emerge to be a major force in the global society. The author explained social media, various social networking sites, and its history. The book gives deep information about the Internet and various other social media models. It also states about the impact on students and society.

Methodology:

The study was conducted in Jaipur. Two colleges were randomly selected. Total Sample size of 80 college students in age group (18-23) were selected randomly for the study purpose. The study will throw light on increasing cyber-crime and aberration by young students with the more usage of Social Networking Sites. The variables examined were age, caste, gender etc. and dependent variables were such as Social networking sites, cybercrime, privacy measures, awareness, laws etc. The data type is Quantitative in nature it is non probability type of sample as the investigator has chosen the respondents of his own choice.

The respondents were given a set of 50 questions for obtaining necessary information.

Objectives:

- 1. To observe the access of Social Networking Sites among College going students in Jaipur.
- 2. To trace the level of awareness among College going students in Jaipur.
- 3. To identify the impact of Social Media on Academics, Social Life, and on the personality as a whole.

Hypotheses:

- 1. Lack of awareness regarding the use of Social Media leads to Cyber Crime.
- 2. Abundant use of Social Media affects academic performance.

Findings:

 There are many Social Networking Sites available on the Internet but Facebook is the most commonly used Social Networking Site among college-going students. Around 45% of respondents have an account on Facebook which is followed by Instagram (35%), LinkedIn (10%), Twitter (7%), and others (3%). The students find Facebook a better platform to communicate with each other in comparison to other Social Media Sites.

- 2. The study states that 68% of the majority of the respondents access Social Networking Sites daily whereas 18% of them use it once in a week. 10% of respondents check once in a Fortnight and 4% of them use once in a month. It depicts that the respondents who access their accounts daily feel the need of socializing through social networking sites.
- 3. It states that 77% of the respondents wake till late at night to access Social Networking Sites and only 23% of them do not wake till late at night for using these sites. Waking till late night causes many health disorders mentally as well as psychologically also such as sleep disorder, depression, frustration, etc and also leads to poor academic performance as they spend much time on these sites, and they devote less time to their Academics.
- 4. The findings state that 81% of the respondents share their personal information on these sites and it has been seen that 19% of respondents who do not post their personal information are less prone to cybercrime comparatively to the respondents who post it regularly. Some of them are also not aware of once the photo or video is shared over the Internet it can't be taken back.
- 5. It states that only 33% of the respondents know about the privacy settings and the laws associated with Cyber Crime whereas 67% of respondents are not aware of the Privacy Settings and The Information Technology Act 2000. It depicts that respondents who have a lack of awareness regarding Privacy Settings and IT Act are more prone to Cyber Crime and most of them have also faced problems like Cyber Bullying, Morphed Images, Hacking, etc.

Conclusion:

It has been seen that upsurge in usage of social media has led to an increase in Cyber Crime among the College going students. Social Media has become the status symbol for the students and a place where they can show a different side of their personality leaving behind the real truth. The more excess usage is affecting their health and also degrading their academic performance leading to cybercrime because of jealousy, frustration, peer pressure, etc. Hence, parents and teachers must focus on this issue and make them aware of the risks associated with the Internet and the laws to protect themselves.
